### **Rental Terms and Conditions:**

- a. The renter agrees to return the vehicle in the same condition as received, except for reasonable wear and tear.
- b. The renter must hold a valid driver's license for the entire rental period and be at least 21 years old.
- c. The renter is responsible for any traffic violations, parking tickets, or toll charges incurred during the rental period.
- d. Smoking and pets are strictly prohibited in the rental vehicle.
- e. The renter is responsible for any damage caused to the vehicle, including theft, vandalism, or accidents, and must report any incidents to the rental provider immediately.
- f. The rental provider reserves the right to terminate the agreement and repossess the vehicle without prior notice if the renter violates any terms and conditions.
- g. The renter agrees to pay for all fuel costs and return the vehicle with the same fuel level as at the start of the rental.
- h. The renter agrees not to sublet or transfer the vehicle to any third party without the rental provider's prior written consent.
- i. The rental provider is not liable for any loss or damage to personal belongings left in the vehicle during or after the rental period.
- j. The renter must adhere to all applicable laws and regulations while operating the rental vehicle.

#### Insurance:

- a. The rental provider maintains appropriate insurance coverage on the vehicle.
- b. The renter is responsible for any deductibles or insurance claims resulting from damage, loss, or accidents during the rental period.

#### Reservation and Cancellation:

- a. A reservation is considered confirmed only upon receipt of a reservation deposit, if applicable.
- b. Cancellation made 12hrs or more before the rental start date will result in a full refund of any reservation deposit.
- c. Cancellation made within 1 day of the rental start date may result in a partial or no refund, depending on the rental provider's discretion.

#### Governing Law:

This Agreement shall be governed by and construed in accordance with the laws of Massachusetts. Any disputes arising from this Agreement shall be resolved in the courts of Massachusetts.

Entire Agreement:

This Agreement constitutes the entire agreement between the Parties and supersedes any prior discussions or agreements, whether written or oral, relating to the subject matter herein.
